- 1. OA, Rules. The Amelia Island Sailing Club is the Organizing Authority for the race, which will be governed by *The Racing Rules of Sailing* (Rules, RRS).

- Mark 2 Saint Marys Entrance Turning Basin Lighted Buoy F (port rounding)
- Mark 3 Cumberland Sound Lighted Buoy Green 27 (port rounding)
- Mark 4 Amelia River Lighted Buoy Red 2 (port rounding)
- Mark 5 Saint Marys Entrance Turning Basin Lighted Buoy F (port rounding)
- Mark 6 Cumberland Sound Lighted Buoy Green 27 (port rounding)
- Mark 7 Saint Marys Entrance Range Front Light and Passing Light (Spider) (STARBOARD ROUNDING)

FINISH LINE – Imaginary line between Amelia River Lighted Buoys Red 4 and Green 5 (LEAVE Red 4 to STARBOARD)

Record your GPS time when the bow of your boat crosses the finish line. A headsail set forward of the bow does not qualify as a finish. This is a change to align with the *Racing Rules of Sailing 2021-2024*, modified 1-1-2021.

 COURTESY BROADCAST: The Race Committee will use VHF Channel 71 to attempt to broadcast information on boats early over the line. Failure to receive or hear such radio transmission will not be grounds for redress. This is a change to RRS 60.1.
