

Notice of Race – June 25, 2022

Committee Boat- Misty (904-210-2087)

All boats should monitor VHF channel 71 for START instructions and ongoing communication during the race

1. OA, Rules. The Amelia Island Sailing Club is the Organizing Authority for the race, which will be governed by *The Racing Rules of Sailing* (Rules, RRS).
2. Schedule of Race (All times GPS) The Race will be a Pursuit Format
 - a. 0945 - Roll Call
 - b. Rebecca's Reach START @ 10:00:00
 - c. Salty Sally START @ 10:06:37
 - d. Misty Start @ 10:11:21
 - e. On Eagles Wings START @ 10:07:50

PHRF time adjustments will be taken at the START, as indicated above

The Committee Boat will give each boat a 6-minute signal, 5-minute signal (engine off), 1-minute signal and START signal for their individual assigned START time above

3. RACE COURSE (approximately 8.1 nautical miles). Forecast at the START, winds from the East at 6-7 knots
4. START LINE – Imaginary line between Saint Marys Entrance Range Front Light / Passing Light (Spider) and Amelia River Lateral Buoy Red 2

Mark 1 – Saint Marys Entrance Turning Basin Lighted Buoy Yellow E (port rounding)

Mark 2 – Cumberland Sound Lighted Buoy Green 29 (port rounding)

Mark 3 – Amelia River Lateral Buoy Red 2 (port rounding)

Mark 4 – Cumberland Sound Lighted Buoy Green 23 (port rounding)

Mark 5 – Cumberland Sound Lighted Buoy Red 28 (port rounding)

Mark 6 - Saint Marys Entrance Range Front Light / Passing Light (Spider) **STARBOARD ROUNDING**

FINISH LINE – Imaginary line between Amelia Rivers lateral Buoy Red 4 and Green 5 (leave Red 4 to starboard)

Record your GPS time when the bow of your boat crosses the finish line. A headsail set forward of the bow does not qualify as a finish. This is a change to align with the *Racing Rules of Sailing 2021-2024*, modified 1-1-2021.

Report your time to Misty on VHF channel 71, or text to mobile phone at 904-210-2087.

5. COURTESY BROADCAST: The Race Committee will use VHF Channel 71 to attempt to broadcast information on boats early over the line. Failure to receive or hear such radio transmission will not be grounds for redress. This is a change to RRS 60.1.
6. RETIREMENT: Any competitor retiring from the race shall immediately notify Race Committee on Channel 71.
7. DISCLAIMER OF LIABILITY: Competitors participate in the regatta entirely at their own risk. See RRS 4, "Decision to Race". The organizing authority will not accept any liability, nor be liable, for any damage, personal injury or death sustained in conjunction with, prior to, during or after the regatta.
